### 1. Have you ever noticed the influence of literature on mainstream cinema?



#### 2. How often do you watch movies adapted from literature?






Figure 3: Success of a movie adaptation wise distribution of respondents


filmmaking is a delicate task, and a successful adaptation often finds a middle ground that respects the source material while embracing the unique language of cinema.
